Subject: Application of Ananya College of Homoeopathy, KIRC Campus, Ahmedabad-Mahesana Highway, Kalol, Gandhinagar – 382721, Gujarat for permission with intake capacity of 100 seats in BHMS course for A.Y. 2023-24 under section 29 of NCH Act 2020 - regarding

Sir,

Ananya College of Homoeopathy, Gandhi Nagar, Gujarat has submitted an application for permission for sanction of 100 seats in BHMS course for the academic year 2023-24. The College has submitted the Part 1 information in which the entire functional profile has been narrated. MARBH has conducted the Inspection for post graduate course on 05.04.2023, followed by hearing on 01.06.2023. MARB has examined the profile of the College as to whether the college fulfils the Minimum Standard requirements to be fulfilled as per the prevailing regulations under NCH Act 2020. As per the observations made by MARBH, following lacunae are to be rectified with immediate effect. College shall fulfil all functional requirements as per the Minimum Standard requirements.

- a. The College authorities did not cooperate in visualizing IP wards during the hearing conducted on 01.06.2023. Patients admitted in the IP wards did not seem to be genuine case.
- **b.** The bed numbers were not in display and a single room was divided for different departments.
- c. Inspection team could not see any genuine patients with clear diagnosis and patients seemed to have been admitted on the day of inspection itself.
- d. Case records were not well maintained with proper Repertorisation, no reference of Repertory selected, no proper investigation and totality of symptoms with basis of selection not mentioned in all cases. Case sheets should have complete demographic details and contact details of patients. Diagnosis should be written in ICD 11 criteria.
- e. On the day of hearing, not even a single intern as well as 3rd & final year students in the OPD were seen. Comments on the same shall be furnished by return mail.
- f. Biometric data does not match with entry in and out time. College did not provide 1 year Biometric of Teaching Faculties.

Considering the above observations, and facilities available, MARB has decided to issue conditional permission to Ananya College of Homoeopathy, KIRC Campus, Ahmedabad-Mahesana Highway, Kalol, Gandhinagar – 382721, Gujarat for conducting BHMS course for the academic year 2023- 24 with intake capacity of 100 seats. All shortfalls mentioned shall be rectified within a period of 30 days or before counseling initiates whichever earlier, and compliance report shall be submitted to the undersigned, failing which the conditional permission issued will be withdrawn without further notice.

All admissions shall be made from NEET qualified candidates only. It is further informed that minimum 15% of seats of the permitted intake capacity of BHMS course shall be treated as All India Quota. Counseling for seats under all India quota shall be conducted by respective Counseling Authority of State/UT govt as designated by Central Government and counseling for the remaining 85% seats or as the case may be, shall be conducted by the concerned counseling authority of the state/UT. The permission of the college stands withdrawn if the college fails to comply with the aforesaid direction of the central govt for All India quota or the student admitted thereunder.

The category wise list of the selected candidates may be informed to the Medical Assessment and Rating Board for Homoeopathy after the process of admission is completed. Any admissions carried out other than NEET qualified students will not be approved by Medical Assessment and Rating Board.
